NMLS-51607	Ability for user to hide/unhide password	For all users in the system, an enhancement has been added allowing users the ability to hide or unhide the password on any screen where the password is entered.	System
NMLS- 50399	Individuals with Federal Cease and Desist Disclosure Action should not be TA Eligible	Individual users who have indicated an action type of “Cease and Desist (Regulatory)” in the Disciplinary Action section of the MU4R will not be eligible for Temporary Authority (TA). This change applies to any historically submitted MU4R filing for the individual, not simply the most recent MU4R filing.	Individual Users (Federal)
NMLS-52306	Instructional Text Changes to MU2/MU4 Disclosure Explanations and Details page.	The instructional text in the MU2 and MU4 filings for both the Disclosure Explanations page and Details page have been updated to remind users not to include personally identifiable information.	Company Users
NMLS-52129	Instructional Text Changes to MU4R Disciplinary Actions list and detail page	The instructional text in the MU4R filing for both the Disciplinary Actions page and Details page have been updated to remind users not to include personally identifiable information.	Company Users (Federal)
NMLS-51496	Capture Effective Date whenever SC or UC name is changed	To support the company name, change process for Surety Companies and Underwriting Companies in which the entity must contact the NMLS Call Center to request the change, the system will now validate that the effective date for the change (entered by the call center agent) is neither earlier than the creation date of the company or a future date. The system will not display the history of name changes entered.	Support Users

NMLS-51289	Surety Bond Rider option for Surety/Underwriting Company name changes	To support the Surety Company/Underwriting Company name change process (referenced above in NMLS 51496), enhancements have been made to the bond rider process to ensure that active bonds in the system reflect the new company name. Bond riders created by the Surety Company/Underwriting Company and Surety Bond Producer will automatically include the name change if the rider effective date is on or after the Name Change effective date. NMLS-50845	Allow SU/EU users to view Review Item Subscriptions	This enhancement will give support users a read-only view of each agency's Review Item subscriptions. Previously, only the agency account administrators (AAs) had access to view the Review Item subscriptions.	Support Users
NMLS-47731	Money Services Business Call Report (MSBCR) - v3 Updates - Fields Changes for Virtual Currency	This enhancement updates some of the fields related to the MSBCR Virtual Currency components. The new version will be available to users after Q1 of 2023.	System
NMLS-49358	MSBCR v3 - Publish new documentation for NMLS Resource Center	New documentation has been created for the NMLS Resource Center that includes updated templates, file specifications, and various example files to better support new users.	Company Users
