	N/A	N/A	REQUIREMENTS FOR CLOSURE OR DISCONTINUANCE OF OPERATIONS: Upload to the Business Plan Section on NMLS documentation and explanations providing sufficient proof, in accordance with Idaho Code 26-2246, that:  • The licensee has remitted to all of its creditor clients all moneys collected on their behalf and due such creditor clients;  • All collection accounts, judgments obtained, and other accounts have been returned to the creditor clients or other proper parties, and if appropriate, assigned by the licensee to its creditor clients or other proper parties;  • All valuable papers, documents, judgments and other property provided to the licensee by its creditor clients or other parties in connection with the collection agency's collection activities have been returned to the creditor clients or other proper parties; and  • All open accounts of any licensable activity have been properly assigned to another licensee or terminated in accordance with any contract with any debtor client.  • A licensee which holds a license issued pursuant to this act, upon closure or discontinuance of its operations, shall maintain the bonds required of such licensee to conduct a collection agency business until a final accounting of its affairs, as set forth above, has been filed with and approved by the director.
