The licensee should submit an amendment and Advance Change Notice within the Company Form (MU1) at least 60 days prior to the proposed change. Upon submission of the ACN, the Department will issue an AFI for the \$1000 ownership change fee.</p> <p><b>No Change in controlling person:</b> A licensee that is an entity other than corporation need not seek prior approval for a direct ownership change where no person proposes to become a new controlling person. The licensee may submit an amendment for non-controlling addition or change in Direct Owners within the Company Form (MU1) in NMLS within 15 days of the change.</p> <p><b>Executive Officers:</b></p> <p>Submit an amendment for an addition or change in Executive Officers within the Company Form (MU1) in NMLS within 15 days of the change occurring.</p>	<b>NMLS</b>

The licensee should submit an amendment and Advance Change Notice within the Company Form (MU1) in NMLS at least 60 days prior to the proposed change. Upon submission of the ACN, the Department will issue an AFI for the \$1000 ownership change fee.</p> <p><b>No Change in controlling person:</b> A licensee that is an entity other than corporation need not seek prior approval for an indirect ownership change with no new controlling person. The licensee may submit an amendment for non-controlling addition or change in Indirect Owners within the Company Form (MU1) in NMLS within 15 days of the change.</p>	<b>NMLS</b>
