

New Application Checklist Jurisdiction-Specific Requirements



MISSISSIPPI MORTGAGE BRANCH LICENSE

Instructions

- 1. **Total license costs: \$321** including the NMLS processing fee. All fees are collected through the NMLS and ARE NOT REFUNDABLE.
- 2. Each branch location, wherever located, desiring to conduct business concerning Mississippi residential property, must be separately authorized and will require a filing of Form MU3 through the NMLS.
- 3. Each branch location is required per statute to have a Loan Originator registered at that branch; therefore, for each MU3 form filed, a corresponding MU4 form must be filed also. After the MU4 is submitted, the company must submit a sponsorship request to the regulator before the individual MU4 license will be approved. - 4. The regulator will review the filling and all required documents and communicate with you through NMLS. To review your status in NMLS, click the Tasks tab and click Work List.
- 5. Jurisdiction-specific requirements as identified on the checklist below must be completed within 5 business days of the electronic submission of your application through the NMLS at the following:
