Who is required to have this license?

The license requirements for premium finance agencies are found primarily in Article 12-B of the New York Banking Law (BL) and regulations thereunder. BL Section 555 provides, in part:

No person except a lending institution or an authorized insurer shall engage in the business of a premium finance agency without a license therefor obtained from the superintendent, as provided in this article.

This license should only be applied for by a company that also holds or is applying for the NY Premium Finance Agency License.

In addition to the items listed in the <u>checklist below</u>, the New York State Department of Financial Services (NY-DFS) may require, as it deems necessary, the submission of any other information or documentation.

Pre-Requisites for License Applications
