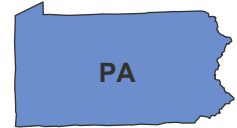




Surrender Checklist

Jurisdiction-Specific Requirements



PENNSYLVANIA PAWNBROKER BRANCH LICENSE

Instructions

1. Licensees must notify the Pennsylvania Department of Banking and Securities within ten (10) days of terminating business under this license. Notification must be made by surrendering the license through the company application form in NMLS
2. You are required to update the Books and Records section of the company application form with the Records Custodian name and the physical location where the books and records will be maintained subsequent to license surrender. If the Records Custodian or location changes after license surrender, you must provide written notice of changes to the Pennsylvania Department of Banking and Securities. Books and records *must* be kept for two (2) years after the date of payment of any loan, or in case the loan is not paid, the records of a pawnbroker shall be retained for a period of two (2) years after the date of the sale of the pledge.
3. Surrender requests will not be processed without receipt of all items listed on the checklist.
4. The acceptance of the surrender request is at the Department's discretion.
5. Pennsylvania does not charge fees for surrender at this time.
6. Agency specific requirements as identified on the checklist below must be received with this checklist within 5 business days of the electronic submission of your surrender through the NMLS at the following:
