### Background Information

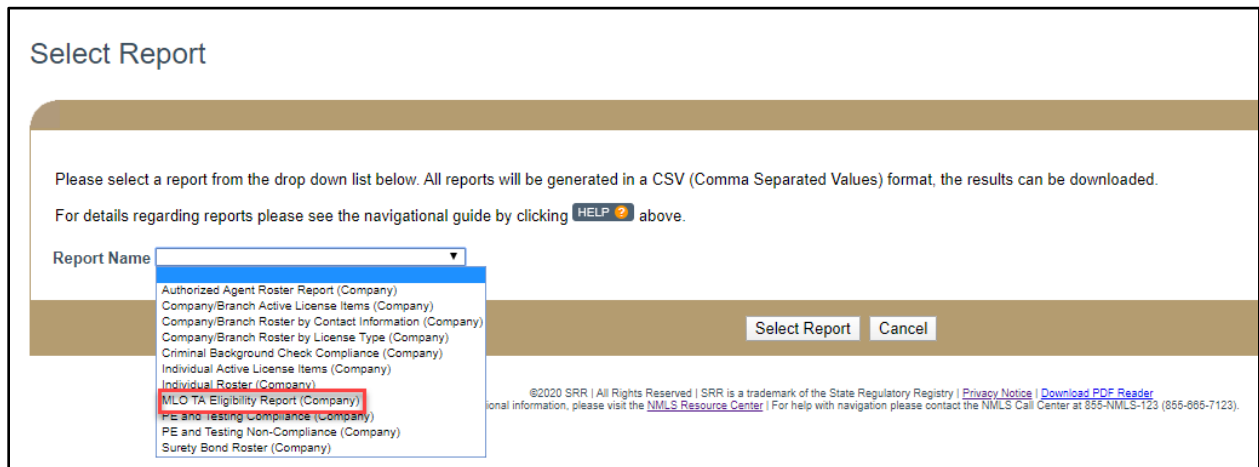
This release incorporates a new report for Company Users entitled “MLO TA Eligibility.” This report displays individuals who granted the company access and would be TA Eligible at application if they have not already been classified as non-W2 employees.


### Access the MLO TA Eligibility Report

1. Log into [NMLS](#) with your company username and password.
2. Accept the Industry Terms of Use.



3. Click the **Reports** tab.
4. Select the **Request New Report** button.
5. Click the **Report Name** dropdown and select the MLO TA Eligibility Report (Company).



6. Click the **Select Report** button.
7. Click the spreadsheet icon  next to the report name to view the results.

8. View the report.
